

The Application/ proposal received from *Karthikeya Educational Trust, No.R-23/A/A2, Ambattur Industrial Estate Road, Anna Nagar [West], Chennai* has been processed as per laid down procedure, guidelines, policy and/ or norms and standards of AICTE, mentioned in *AICTE Regulations* and/ or *AICTE Hand Book for Approval process*.

I am directed to state that on consideration of the report of the Expert Committee and on the recommendations of the *State Level Committee* the All India Council for Technical Education (AICTE) is pleased to accord approval for establishment in the name & Style of *Karthikeya Polytechnic College, Near Andavar Kovil NG-45, Kulithalai Road, Kannudaiyanpatti Village, Manapparai, Tiruchirapalli District* for the academic year 2008-2009 to conduct *Diploma Level Course(s)* in Engg. & Tech. with an annual intake as given below:

The approval accorded is subject to fulfillment of the following conditions:

- 1. The institution shall fulfill all the conditions, if any, within three months from issue of this letter. Non-fulfillment will lead to *withdrawal of approval* without the need of any more opportunity, as the institution is well aware of the deficiencies.
- 2. The institution must have affiliation from the affiliating body for the above courses before making admission. In the absence of such affiliation, this letter of approval shall be treated as withdrawn.

The Institution must appoint Principal and other Full Time Faculty members as per AICTE Norms with Pay scales as prescribed by AICTE, before making any admissions.

All the required Laboratories/Workshops/Machineries/Equipments must be under operational conditions before making admissions.

No excess admission shall be made by the Institution during the academic year.

The approved course(s) shall commence as per the academic calendar of the Affiliating Body.

The approval is valid only for the academic year 2008-2009. This Approval Letter will not be valid for making any admission for the subsequent years.

Name of the Institution, Name of the Society/Trust, are not allowed to be changed without prior approval of AICTE. The name and title of the Institution should be such that "the Emblems and Names (Prevention of Improper Use) Act 12 ("1950" of Government of India) is not violated in any manner.

In exercise of power conferred under 10 (p) of the AICTE, Act, AICTE may inspect the Institution any time it may deem fit to verify the progress/compliance or for any other purpose.

Any other condition(s) as may be specified by AICTE from time to time.

Consequent to the Supreme Court Judgement the Model constitution of Governing Body as notified by AICTE in its approval Regulations 1994, stands overruled. It has been decided that while AICTE will not insist of any nomination in the Governing Body of Private unaided institutions, the Affiliating Body/ State Government shall impose minimum condition of affiliation, such as, prescription of qualification of Governing Body Members, in order to ensure academic excellence. The condition so imposed will be subject to scrutiny by AICTE, wherever necessary, to ensure that the same are not unreasonable restrictions".

"It shall be desirable for the private unaided institutions to induct at 50% of members of the Governing Body drawn from renowned academia, academic administrators, subject field experts and a professionals from industry in order to seek their innovative ideas for continuous improvement in the delivery of teaching learning process, matching best practice elsewhere and achieve excellences".

In the event of infringement/contravention or non-compliance of the above conditions and /or the provision of AICTE Act & Regulations/Guidelines/Norms & Standards as prescribed by AICTE, further actions leading to "Reduced Intake" or "No Admission" or "Withdrawal of Approval", may be taken by AICTE and the liability arising out of such actions will be solely that of the Management of the Institution.

The Council reserves the right to visit the Institution any time it may deem fit to verify the compliance of the conditions and standards of AICTE.
